STANDARD OPERATING PROCEDURE FOR JAN KALYAN SHIVIR

1. PM-SETU(Pradhan Mantri Skilling & Employability Transformation through up graded ITIs)

Flagship Centrally Sponsored Scheme –

(Implemented by Ministry of Skill Development & Entrepreneurship, Government of India)

Objective: The scheme aims to transform Government ITIs into modern, industry-driven skill development centres through the **Hub & Spoke Cluster Model**, thereby enhancing intake capacity, infrastructure, and industry alignment.

Coverage: 51 ITIs in West Bengal will be upgraded under the scheme: **11 Hub ITIs and 40 Spoke ITIs**

Beneficiaries: Youth seeking vocational training, ITI trainees, Vocational trainers, Industries requiring skilled manpower.

Key Features:

Modernization of ITIs with upgraded infrastructure, digital learning facilities, and industry-aligned trades/courses.

Industry participation through Special Purpose Vehicles (SPVs) and Anchor Industry Partners (AIPs).

Enhanced placement opportunities via apprenticeships and industry-linked training.

Increased intake capacity to accommodate more students.

Benefits to Students:

Access to upgraded infrastructure and modern equipment.

Training in emerging technology courses.

Apprenticeship opportunities with industry partners.

Improved placement support through industry linkage.

Procedure & Mechanism:

Students **do not apply directly** to PM-SETU.

Benefits are available through **admission to Government ITIs upgraded under the scheme**. Candidates must follow the **normal ITI admission process prescribed by the State Government**.

Admission Requirements:

Documents generally required for admission in PM-SETU upgraded ITIs:

Proof of age, Educational qualification certificates, Identity proof, Aadhaar Card, Caste certificate (if applicable), Passport-size photographs.

Access to Facilities: Enrolled trainees automatically receive upgraded facilities, industry-linked training, apprenticeships and placement support.

2. Prime Minister Internship Scheme (PMIS)

Centrally sponsored Scheme of Ministry of Corporate Affairs (MCA), GoI.

Age limit: Indian citizens aged **between 18 to 25 years** (as on application date), not in full-time employment.

Education: 10th/12th, ITI, Diploma, UG/PG (e.g. B.A./B.Sc/B.Com/BCA/BBA/B.E./B.Tech/M.A/ M.Sc/ M.Com/MCA/M.Tech)

Income: Income of any family member of the intern should be within Rs. 12 Lakh per year.

Duration: Either **6 months** or **9 months** (depending on job role or qualification)

Financial Assistance: **Rs. 9000/-** (90% MCA share through DBT & 10% Company share through CSR/own fund). Additional one-time grant of Rs. 6000/-.

Benefit: Through this Scheme, youth will gain exposure to real-life business environments across varied professions and employment opportunities.

3. National Apprenticeship Promotion Scheme (NAPS)

NAPS is a centrally sponsored Scheme of Ministry of Skill Development & Entrepreneurship (MSDE), GoI, governed through Apprentices Act 1961.

Public & Private Industry Establishment delivers skill training through Earn while Learn Model.

Age limit: Minimum 14 years. No upper age limit but if Industry wants to avail DBT (Direct Beneficiary Transfer) benefit, the upper age limit of candidates is 35 years.

Beneficiaries: Pass outs of Class 5 to Class 12 including ITI pass out candidates.

Eligibility Criteria of Industry for engaging Apprentice: Industries, having employee strength 30 or above, mandatorily have to engage Apprentice 2.5% to 15% of their employee strength. (For industries having employee strength 4 to 29, it is optional to engage apprentices).

Duration: 6 months to 2 years (depending on job role or qualification)

Stipend: Minimum Rs. 6800/- to Rs. 10,560/- (depending on entry qualification). State Govt pays additional monthly stipend of Rs. 1500 (Rs 2500 for outside State).

Benefits: addresses the skill gap of industry and enhances availability of industry-ready man-power. Financial support from the Govt. through NAPS (up to Rs. 1500/- per month per trainee).

4. National Apprenticeship Training Scheme (NATS)

NATS is a centrally sponsored Scheme of the Ministry of Education (MoE), GoI, governed through Apprentices Act 1961.

Public & Private Industry Establishment delivers skill training through Earn while Learn Model.

Age limit: 18 years or above.

Education: Diploma (Engineering and General) or Graduate (Engineering and General) candidates can apply.

Eligibility Criteria: Candidates must not have any prior full-time work experience or have previously undergone Government sponsored apprenticeship training.

Duration: 6 months to 1 year.

Stipend: Minimum Rs. 10,900/- to Rs. 12,300/- (depending upon entry qualification).

Benefits: bridges the gap between academic education and industry requirements.
Financial support from the Govt. through NATS (upto Rs. 4500/- per month per trainee).

5. Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY)

Eligibility criteria:

The scheme targets rural poor youth in the age group of 15–35 years from households identified under rural development programmes. The upper age limit is relaxable up to 45 years for women, persons with disabilities, and other vulnerable groups. Priority is given to SC/ST candidates, minorities, women, and economically weaker sections.

The scheme is implemented in collaboration with the State of West Bengal, following a funding ratio of 60:40 between the Government of India and the State Government.

How to apply:

Eligible candidates may register through authorized DDU-GKY Project Implementing Agencies (PIAs) or through District Project Managers (PBSSD), or any approved designated training centres.

Districts often conduct mobilization drives and community engagement programmes to increase participation and outreach of the programme.

Required Documents :

Beneficiaries should possess valid identity proof (generally Aadhaar Card), residence proof, educational qualification documents, bank account details, passport-size photographs and fulfill eligibility norms prescribed for the respective training courses.

Benefits:

On successful completion of training and assessment, candidates receive certification and placement assistance. Post-placement tracking and support are also provided for retention and career progression of the candidates.

DDU-GKY focuses on inclusive growth and aims to bridge the skill gap among rural youth by connecting them with organized sector employment opportunities across India and abroad.

In West Bengal, the scheme is promoted through residential training with emphasis on quality standards and industry partnerships.

6. Utkarsh Bangla

Eligibility criteria:

The scheme is intended for **unemployed youth, school/college dropouts, job seekers, and individuals** seeking skill upgradation. Generally, candidates aged 15–45 years are eligible for Short-Term Training programmes. Under RPL & RPL Cum Bridge, age and prerequisite educational qualification are not considered as any bar. Validation of prior work experience would be required for RPL & RPL Cum Bridge.

Required Documents :

Eligible candidates should possess a valid address proof, identity proof, age proof, active bank passbook (for DBT stipends), passport photograph and official marksheet verifying educational eligibility to fulfill the educational and age criteria prescribed for the respective job role.

How to apply:

Applicants may enroll directly on the official portal at pbssd.gov.in or physically at any accredited Training Centre (TC) or contact respective District Project Management Units

Benefits:

100% Free Programme: Utkarsh Bangla is a completely free Government initiative. No training partner or agent can charge fees for registration, books, learning kits, or job placement assistance. Certified individuals access localized placements and the Rojgar Seva Portal.

7. Centrally Sponsored Scheme of Vocationalisation of School Education (CSS-VSE)

Under the Samagra Shiksha Mission, vocational education is offered to students of Classes IX, X, XI and XII as an optional elective subject.

The State presently imparts vocational education across 16 vocational sectors Under the Directorate of Vocational Education and Training.

Each school has the flexibility to select any two sectors based on local requirements and employability prospects.

Eligibility: Class VIII Pass for admission to Classes IX–X.
Class X pass for admission to Classes XI–XII.

Benefits:

Industry-aligned vocational education along with regular schooling.

Skill Certificates in designated job roles after successful completion of Class X and Class XII.

Enhanced opportunities for employment, entrepreneurship, higher education, and skill development.

Eligibility for lateral entry into Diploma Engineering and Technology courses for students with Vocational Education and Science subjects in Higher Secondary).

8. Introduction of Vocational Education & Training under WBSCT and Vocational Education and Skill Development

Short -term vocational training and Higher Secondary Vocational courses have been running in the state in Vocational Training Centres(VTCs).

Total strength: At present, there are 2585 numbers of VTCs.

A. State Funded Vocational Education (VTCs): conduct Short Term Training Programs (STTP)

Educational Qualification: 8th pass

Age limit: 14-40 years

B. HS Vocational (H.S Voc):

Educational Qualification: 10th or equivalent

Age Limit: 14-40 years

Benefits:

i) Upon successful completion of the Short Term Training Programme (STTP), trainees gain opportunities for employment in various industries. The programme also equips them with the skills required for entrepreneurship and self-employment.

ii) Upon successful completion of the Higher Secondary Vocational [H.S. (Vocational)] course, students can pursue employment opportunities in industries or start their own ventures through entrepreneurship and self-employment. In addition, since the qualification is equivalent to Higher Secondary (Class XII), students are eligible to pursue higher education and professional courses.

9. Common Admission in ITIs & Polytechnics through centralized Portal

Introduction: From 2024 onwards, the admission process for both Polytechnics and ITIs was unified and made merit-based, considering marks obtained in board examinations to promote better enrolment through a Common Admission Portal, facilitating seamless online registration, application submission, secure payment processing, verification, merit list generation, choice filling and preference selection, seat allotment, admission and sharing of data with the respective Councils.

Current status: For Academic Year 2026-2027, applications through CAP are ongoing in Engineering & Technology, Pharmacy and ITI courses.

Admission for Academic Session 2026–2027 has started. Currently, 99621 candidates have registered on the Common Admission Portal with 48,746 applications for Diploma courses and 48600 applications for ITI trades.

10. Job Fair through Rojgar Seva Portal

Job fair is organized through Rojgar Seva Portal which is a digital platform designed to facilitate seamless interaction between verified and registered industries and certified skilled trainees in West Bengal. Operates at District levels across West Bengal. It aims to streamline employment opportunities through transparent, technology-enabled processes.

So far, 5700 industries have onboarded the Rojgar Sewa Portal and raised requisition against 111891 vacancies in 354 Job Roles.

Benefits:

The Rojgar Sewa Portal has emerged as a robust digital platform that effectively bridges the gap between job seekers and employers across the State.

By eliminating geographical barriers and streamlining recruitment through structured, web-enabled Job Fairs, it ensures equitable access to employment opportunities for skilled youth.

The portal enables industries to reach a diverse, certified talent pool while offering candidates a chance for employment and apprenticeship opportunities.

The Rojgar Sewa Portal has helped to aid technology-driven, industry-linked employment facilitation in West Bengal.
