Regarding: Submission of requisition of 'Taruner Swapno' scheme for class XI students through i-OSMS portal for the Financial Year 2025-26

Head of the institutes of all running grantee VTCs of the State conducting H.S. (Vocational) courses are requested to enter bank account details of the eligible regular students of Class XI and to submit the requisition for the financial assistance under 'Taruner Swapno scheme' in the Financial Year 2025-26 through the i-OSMS portal of DVET. Schedule for submission of requisition is given below:

Sl No.	Activity	Period
1	Submission of requisition after verification of bank account details for students of class XI by the VTCs and forwarding to the concerned Nodal Office.	26.11.2025 to 06.12.2025
2	Forwarding the requisitions after necessary verification to the concerned Regional Office by the respective Nodal Office.	26.11.2025 to 09.12.2025
3	Forwarding requisitions to DVET by the Regional Office.	26.11.2025 to 11.12.2025

• Before submission of the requisition following points have to be considered by the HOI:

1. The student has been registered in class XI with WBSCTVE&SD in the year 2025 only.
2. The student is not dropout and he/she is continuing education till date.
3. Mandatory fields:
 - a) Primary details of the eligible student,
 - b) Student Code of the eligible student in 'Banglar Shiksha Portal' (upto class X),
 - c) Own bank account no. of the student with detail (Bank A/C in the name of other than the student will not be entertained). Once the data are finalized

from the VTC end, those data cannot be edited/corrected later on.

4. Confirmation about the student that he/she has not registered his/her name in 'Banglar Siksha Portal' or anywhere to get the financial assistant under the 'Taruner Swapno scheme' in F.Y. 2025-26 or before.


- Hol of VTCs are also requested to submit the hard copies of the below listed documents to the concerned Nodal Offices under DVET after completion of the online work through the i-OSMS Portal:

i) Authenticated copy of active bank account (in the name of the eligible students only) details (e.g. Passbook page of bank account/cancelled cheque) where the submitted bank account number & IFSC etc. are clearly mentioned.

ii) The system generated, downloaded, and printed copy of the requisition from the i-OSMS Portal for 'Trauner Swapno' Scheme which is duly signed and sealed by the Hol.
